The only problem defendant has is that the witness did not testify to statements he made in his prior declaratory judgment proceeding. This does not allow us to assess whether the statements were probative of defendant's credibility or truthfulness. Indeed, it appears defendant is trying to argue that his testimony was truthful and the previous statements were not. But this claim goes to the weight of defendant's testimony, rather than its admissibility, and this court has concluded his statements were properly admitted to impeach his credibility. (People v.
